Please read before signing, as this constitutes the agreement as a volunteer and the understanding of your working relationship as a volunteer with Nehemiah's Vision, Inc.

In the event that Nehemiah's Vision, Inc. arranges accommodations, I understand that Nehemiah's Vision, Inc. will not be responsible for my personal effects and property and that it will not provide lock-up or security for any items. I will hold Nehemiah's Vision, Inc, its officers, directors, and participants harmless in the event of theft or for loss resulting from any source or cause. I further understand that I am to abide by whatever rules and regulations may be in effect for the accommodations at that time.

I understand that parents are responsible for children that are minors and the church group leader is responsible for youth that are under age 18.

I understand that this form will remain in effect for this project and all future projects unless written notice is given by myself or a representative of Nehemiah's Vision, Inc.

By my signature, for myself my estate and my heirs, I release, discharge, indemnify and forever hold my local Baptist church, Golden Triangle Baptist Association, Southern Baptist Convention of Texas, Baptist General Convention of Texas and Nehemiah's Vision, Inc. together with their officers, agents, servants and employees, harmless from any and all causes of action arising from my participation in this project, and travel or lodging associated therewith, including any damages which may be caused by any negligence of such released parties.
